Call.blast Communications, LLC is providing users ("User") with access to its telephone messaging services and web site, (the "call.blast Service"), subject to the terms and conditions of this User Agreement (the "Terms of Use"). Any new features, changes, updates or improvements of the call.blast Service, and the availability of new call.blast services, shall be subject to the terms of this User Agreement unless explicitly stated otherwise.

CALL.BLAST PRIVACY STATEMENT

Call.blast Communications, LLC has implemented this privacy policy to ensure that personal information pertaining to our clients is kept private and secure subject to this Terms of Use Agreement.

Call.blast Communications, LLC will not distribute any of the information we receive from you while using the call.blast voice broadcasting service. Financial information and other information deemed critical by call.blast Communications, LLC will be exchanged over a secure connection and encrypted within our database.

Call.blast Communications, LLC does not have, and does not plan to have, any relationships with third parties that would want or require your personal information.

YOUR CONDUCT

As a condition of your use of the call.blast Service, you agree and warrant to Call.blast Communications, LLC that you will not use the call.blast Service for any purpose that is unlawful or prohibited by the User Agreement.

Specifically, you agree and warrant to Call.blast Communications, LLC that:

1. You will not use, or attempt to use, the call.blast Service to convey any information that may be considered unlawful, harassing, libelous, abusive, threatening, obscene, hateful, offensive, harmful, vulgar, distasteful, defamatory, indecent, objectionable, or invasive of another person's privacy or proprietary rights.
2. You will follow the letter and spirit of the terms of the User Agreement and all applicable laws,
3. You will not use, or attempt to use, the call.blast Service in connection with any junk messages, spamming, advertising or messages that are duplicative, unsolicited, or promotional in nature;
4. You will not send, or attempt to send, messages to emergency lines, to any health care facility or similar establishment, to numbers assigned to radio common carrier services or to any service for which the called party is charged for the call;
5. You will not impersonate, or attempt to impersonate, any other person, falsify contact information, misrepresent a relationship with any person or entity, including misrepresenting a relationship with call blast, or otherwise attempt to mislead others as to the identity of the sender or the origin of a message;
6. You will not resell, or attempt to resell, the use of the call.blast Service without express, prior written consent/permission from call.blast Communications;
7. You agree and call.blast Communications retains the right, at its sole discretion, to determine whether or not User's conduct is consistent with the letter and spirit of the User Agreement. call.blast Communications, LLC may immediately terminate User's call.blast account if User's conduct is found to be inconsistent with this User Agreement.
